## 13. CEO Update

Steven George reported cash needs to be reconciled as well as bank statements. Need to code invoices correctly. Training still needed for front offices and revenue cycle. Steven George has started receiving a daily collection sheet from the clinic to show patients and amount collected or not collected from patients. Need three providers in the clinic. Need to renegotiate contract for Dr. Mark McKinnon. May outsource weekend ER call. Home Health Department needs training. During the last home health survey, the department was dinged for not having a backup RN. Steven George feels Home Health is overstaffed. Charts for Home Health seem to be doing well. Would like to have two physical therapists. Personnel have a weekly call with Truebridge. Truebridge is not following up on claims. Wants AR aging from Truebridge mainly on commercial insurance. Truebridge rep can't give all answers of questions asked. Mr. George is not happy with the coding company. Charts needs to be closed within 48 hours. As of today, North Runnels Hospital owes Truebridge \$633,000.00. Truebridge wants \$44K per month as of 11/1/2024. Hoping bankruptcy is filed by 11/1/2024. Provider training needed on medical necessity. Marketing personnel feels there are some lab tests that are available for revenue.
